To comply with NAR's new Core Standards program, we have also added an optional \$15 above-the-line RPAC donation, to which we hope you will contribute. National Association of REALTORS®

• NAR was instrumental in securing many provisions benefiting REALTORS<sup>®</sup> and property rights relating to the QRM rule. As originally proposed, the QRM rule would have narrowly defined QRMs to require a 20 percent down payment. NAR and its coalition partners gathered the support of 44 U.S. Senators and 282 House members, who wrote to regulators expressing their intent on QRM and opposing the sizable down payment requirement.

Massachusetts Association of REALTORS®

- This year, MAR was credited with amending a bill that would have prohibited real estate licensees from providing broker price opinions (BPOs) unless they also held an appraiser's license. MAR successfully amended the bill to include an exception for real estate licensees who provide BPOs in the normal course of business.
- MAR offered free webinars to members on hot topics such as TRID, solar and clean energy, flood insurance, and business planning just to name a few!

## Northeast Association of REALTORS®

- At NEAR, our committees, volunteer leaders, and staff have worked together to enhance and improve member services, especially information, education, and networking.
- Offered free dual-credit (MA & NH) CEs monthly for members as well as free and low-cost professional development courses.
