

These rules and regulations are part of the contract for exhibit space. Oregon Association of School Business Officials reserves the right to render all interpretations and decisions should questions arise and to establish further regulations as may be deemed necessary

for the general success of the show. Oregon ASBO's decisions and interpretations will be accepted as final. Oregon ASBO will provide display space as indicated in this agreement but reserves the right to make any changes necessary for the general success of the show. Exhibitors may not schedule meetings or events during any scheduled Oregon ASBO sponsored event, including evening activities. The exhibit hall will be staffed by a security guard when exhibits are closed. However, do not leave valuables in the hall.

in the exhibit fee. Thursday lunch is not included in the exhibit fee and tickets must be purchased in advance on the exhibit registration form.

Fees must be paid in full, to guarantee booth space. If fees are not received by June 27, Oregon ASBO reserves the right to resell the space.

Exhibitors are allowed two representatives free of charge per 8' x 8' booth. Additional representative registrations are available for \$20 per person. The names of the representatives must be submitted to Oregon ASBO by June 27. Names submitted or changed after June 27 may be subject to a \$20 charge.

CANCELLATION POLICY

All cancellations must be submitted in writing to Oregon ASBO. Registration and activity fees are refundable before June 13, 2014, less a \$100 fee. No refunds will be made after June 13, 2014, unless the space is sold.
